**ANNUAL EVERGREEN COMMONS  
PARK WORKDAY!**



Join your neighbors in the fresh air and sunshine to clear away winter and bring on the summer! Work includes: trimming, pruning, painting, weeding preparing planting areas for flowers, planting flowers and other miscellaneous work. We will need you to bring spades, and shovels, rakes and wheelbarrows for hauling woodchips and tree cuttings.

Each household that contributes four (4) hours of work is excused from the \$40 park fee. Arrangements can be made for those unable to participate on April 28. Please contact Marvin Potts at 481-9642 or Dick Pryor at 834-7380 for arrangements if you are unable to participate on **Saturday, April 28**. A BBQ lunch, sodas and beer will be provided at noon lunch for all workers and their families.

There will be curb-side collection sites available on Cool Ct., The Ct., Zephyr Way and the Park Green parking lot. Personal refuse may be brought to the Park Green Parking lot, Cool Ct., The Court and Zephyr Way sites which will be marked **April 29** and the piles picked up by the County on Thursday, **May 3rd**. Please do not put out any material until the sites have been marked. A copy of acceptable and unacceptable materials is shown on the reverse of this flyer.

All material can be stacked in one pile as the County does not separate the green material from the trash. Electronic materials (computers, printers, etc.) should be placed to the side of the trash pile. Take special note of the list of unacceptable materials and do not place in the piles. If you have **large amounts of fence materials** or tree and shrub pruning, please call 875-5555 to make arrangements for the County pick up.

### ACCEPTABLE MATERIALS

- Appliances\*
- Books, TVs and computer monitors
- Universal Waste (Batteries, Light Bulbs, Successor Light Bulbs - less than 4" and not glassed)\*
- Tires (air tire maximum of 5)\*
- Tires (airless)
- Pipes
- Lumber
- Towing Bars/Brake Linings
- Tires

• Lumber pipes and fittings: steel not coated  
 3000 inches in diameter and FIVE feet in length.

\*Place these items to the side of your pile.

### UNACCEPTABLE MATERIALS

- Commercial Waste
- Tin, Rocks, and Bricks
- Glass Panels
- Concrete
- Vehicle Bodies
- Household Garbage
- Tires Axles
- Heavy Materials (like auto bodies, engines, etc.)
- Hazardous Waste (like car oil, chemicals, etc.) - this material may be dropped off at the Fairfield Hazardous Waste Collection Facility located at the North Area Recovery Station. Call 878-5633 for hours.
