TREASURER - LYNNETTE PURVIS

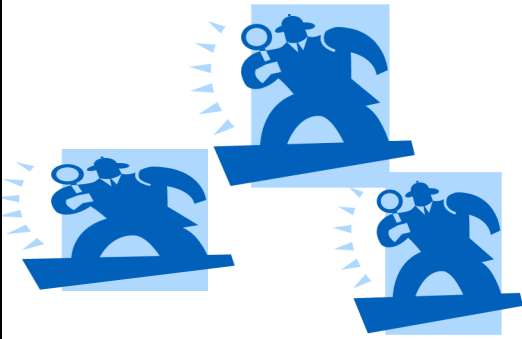
