

Happy New Year!

Our thanks to the vast majority of our homeowners who keep their accounts current.

Delinquent accounts are down in number of lots and dollar amount. Some delinquent accounts are for fees on prior late payments.

Assessments are due the <u>first of the month</u> for the new quarter. A number of people incur late fees by trying to delay until the end of the grace period (the 15th) to make their payments. Some homeowners fail notice the resulting late fee on their next statement, and those in turn become overdue charges.

Good news: we are not raising the quarterly assessment in 2022. The quarterly assessment will remain \$164.00, a total of \$656.000 for the year. For those who wish to pay the full year, there is a \$20.00 reduction, for a payment due of \$636.00.

Because of delays in the budget and therefore the mailing of the statements, we are extending the deadline this one time to January 31 rather the standard 15th of the month.

Please be sure to check your statement to make certain you are current and you pay the correct amount. You can also access your account at any time to check your balance at https://portal.riversidemgmt.com.

Again, we appreciate and thank the vast majority of our homeowners who stay current.
