

Our thanks to the vast majority of our homeowners who keep their accounts current.

In January we waived all late fees for payments that arrived by January 31. Unfortunately, some homeowners received penalties that showed on the April 1 assessment. These late charges were removed in March, after the April 1 invoices were mailed. The reversal of charges will be on the July 1 invoice.

Workday assessments are also included in the July statement. Homeowners who participated the Park Work Day or made other arrangements will have this assessment waived.

Please be sure to check your statement to make certain you pay the correct amount and remain current. There are a few lots that have a small amount due because of some sort of error in the amount paid or because late penalties were incurred and not paid with the next assessment. 
Neighborhood watch block captains will be contacting their neighbors about updating records of owners/tenants in our HOA.
