

Bulky Waste Pickup

June 21, 2022 Update: The Bulky Waste Pickup appointment schedule continues to be significantly limited. A limited number of Bulky Waste Pickup appointments may be available starting mid/late July and gradually increasing to a full schedule late this summer 2022. The temporary service interruption is necessary for training newly hired employees to double route frequency for weekly curbside collection of organics starting July 2022.
